Updated Rate Action Implementation Schedule and Matrix of State and Policy Series – November 14, 2008

This month, we will begin implementing the rate action in Maryland PCS I and PCS II, Nevada Other Pre-PCS, and Virginia Other Pre-PCS. Producer notification mailings will begin November 26, 2008, and policyholder mailings will begin December 2, 2008.
